



Summer 2026 Opportunities Information: London Scholars and New York City Scholars

As members of the London Scholars or New York City Scholars program, students may be eligible to enroll in courses at Northeastern University Boston, Northeastern University Oakland, or the Summer In program hosted on Northeastern's London, Oakland, Seattle, and Portland campuses for summer sessions to continue their program of studies.

[Summer In](#) is an immersive program that lets Northeastern undergraduate students earn eight credits toward their major, minor, or concentration at one of our global network campuses during Summer Session A and B. Students will go beyond the classroom with local industry connections, cultural exploration, and one-of-a-kind networking—all while staying on track or even accelerating their path to graduation. Summer Session A and B Schedule

Northeastern's Boston, London, Oakland, Seattle, and Portland campuses offer summer opportunities in two sessions: Session A and Session B. Programs spanning both sessions run for 15 weeks.

- Session A: May 6–June 21, 2026 (7 weeks)
 - Summer In at NU Seattle begins May 13
 - Summer In at NU London begins May 5
- Session B: June 29–August 16, 2026 (7 weeks)

Advising and Registration

Summer In Registration

Summer In courses in London, Oakland, Portland and Seattle can be found through the [Summer In website](#). Applications for Summer In are open until March 15, 2026. Course registration will take place after applications close. A student's eligibility will be reviewed upon submission of their application.

Summer Course Registration

Summer course offerings for Northeastern's Boston and Oakland campuses will be posted on Monday, February 2, 2026, and registration for summer courses will occur from Monday, February 23, through Friday, February 27.

- Students are issued a time ticket based on earned and enrolled hours, which determines their registration date and time.
- Course registration is offered on a first-come, first-served basis, and it is possible to register at any point after the date and time indicated in the given time ticket.
- For instructions on how to build a plan, search for classes, and register, please review this ["Registering for Classes"](#) guide from the Registrar. Students can work with their on-site first-year advisor to discuss their summer course options.

- Session A and Session B summer sessions are condensed and half the amount of time of a regular semester. Due to the intensive nature of the half-summer sessions, it is strongly recommended not to take more than two classes per summer session.

Enrollment in summer courses, including online courses, depends on availability.

Registration is not guaranteed. Students who enroll at a campus for Summer A, B, or full Summer will have access to university services on that campus beginning in the summer term of enrollment for the summer session only unless continuing at that campus for Fall.

Transfer Credits

New York City Scholars and London Scholars students also have the option of taking courses at a local college over the summer and transferring credits. This is the last summer Scholars will have this opportunity.

Students must first confirm that the courses they are interested in taking are in the Northeastern database. If the courses are not in the database, we strongly discourage students from taking them, as we cannot guarantee the credits will transfer. We recommend not taking any pre-requisite courses from another institution for courses students plan to take in the fall semester. Transfer credit cannot be used for any Fall 2026 course registration until the final transcript is processed and posted on their record.

Students who choose this option will need to earn a C equivalent minimum grade for transfer credit.

Summer Session Eligibility

Eligibility for summer courses depends on the student's program, and on whether the student is a domestic student or an F-1 international student.

Please refer to the table below for more information:

**Summer Session A Courses must not have a pre-requisite that is being taken in the spring in order to ensure that the student is eligible for the course.*

U.S. Domestic Students

U.S. domestic students in the London Scholars program are eligible to take Summer Session A with no pre-requisites in the spring semester and Summer Session B courses.

Due to the New York City Scholars program calendar, students are only eligible to take courses in Summer Session B.

International Students

F-1 international students in the London Scholars program are eligible to enroll in Summer Session A courses only at Northeastern University London.

Please note: F-1 students are required to maintain on-ground, full-time enrollment throughout the entire duration of the summer semester and cannot enroll only in part of a term. Due to the timing of the end of the spring term in London, and the beginning of the summer semester in Boston, F-1 students are not eligible to begin their program in the U.S. during the summer term.

Visas for London Scholars Students

Federal regulations require F-1 non-immigrant students to maintain full-time enrollment with appropriate on-ground presence during all required academic terms. Since summer term is a required term if it is a student's first term of study in the U.S. in F-1 student status, F-1 students are not eligible to begin their program in the U.S. until the Fall 2026 term.

London Scholars students that require F-1 status to study in the U.S. will need to apply for an I-20 to begin the process of applying for an F-1 visa for studying in the U.S.

Internationals students will receive updates this spring from the Office of Global Services (OGS) Boston to their Northeastern email address about this process, including details on applying for an I-20, applying for an F-1 visa, and maintaining F-1 status in the U.S.

Student Financial Services and Billing

Summer courses will be billed at a per credit hour rate of \$2,125 or the Summer Session rate of \$16,998 per session. More information on billing can be found [here](#).

University Housing

Northeastern University Boston

If a student is interested in university housing on Northeastern's Boston campus during the summer term of their program year, they must be enrolled in at least one Boston on-ground course for the duration of the summer sessions that they are living in university housing for.

Rates for Summer Session A or B are typically half of a full-semester rate— if students are staying for both summer sessions, the cost is equivalent to the full Fall/Spring semester rate.

University housing rates range between roughly \$2,700 to \$4,600 per summer term. More information can be found on Housing and Residential Life's Room Rates page. Please note that meal plans are not included in that rate; more information about meal plans can be found on the [Husky Card Services page](#).

Please keep in mind these preferred deadlines for housing applications & deposits when applying for Northeastern housing for summer sessions:

- Summer Session A housing preferred deadline is March 1, 2026.
- Summer Session B housing preferred deadline is May 1, 2026.

Northeastern University Oakland

University housing will be available on Northeastern's Oakland campus for the summer sessions during which courses are offered. Additional summer housing information for the Oakland campus, including housing applications, will become available in the coming weeks.

Northeastern University London

Students who are interested in university housing on Northeastern's London campus during the summer sessions must be enrolled in the Summer In courses at Northeastern University London and will stay in an ensuite room at Hayloft Point.

Please note: Students will not be permitted to remain in their Fall/Spring term room during the summer period. Students are required to relocate to their assigned summer allocation at Hayloft Point prior to the start of the Summer In program on May 4.

Students will need to vacate their assigned summer room no later than 10 a.m. on Monday, June 22nd. Extensions beyond this date will not be granted under any circumstances.

The housing cost for the Summer In program at Northeastern University London is \$4,997. This fee includes the room itself, along with new kitchen and bedding packs to ensure students have everything they need for a comfortable stay.

If students stay in London to complete the Summer In course(s), they will not be charged for housing accommodation from April 27, 2026 - May 3, 2026.
